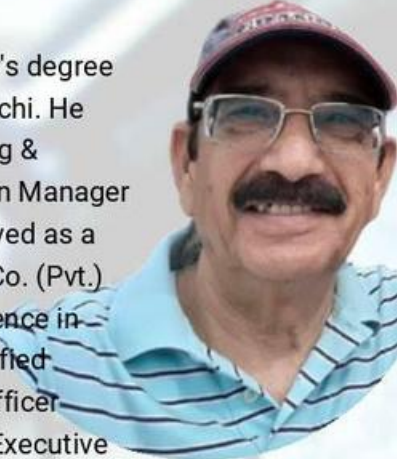
MS. SUMAIRA ANWAR |ASO
